**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY ENGINEER TO CALL FOR BIDS FOR THE  
CURB RAMP AND DRAINAGE IMPROVEMENTS PROJECT 2004**

**WHEREAS**, a need for improvements and repairs to existing curb ramps and drainage facilities have been identified in various locations of the City in conjunction with its Asphalt Concrete Overlay Resurfacing Program; and

**WHEREAS**, curb ramp and drainage improvements will enhance pedestrian accessibility and safety; and

**WHEREAS**, improvements will be built according to Americans with Disability Act, California Code of Regulations Title 24 and City construction standards; and


**WHEREAS**, project cost will be funded by Measure A, Gas Tax and Storm Water Utility Fees programmed for this purpose.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to call for bids for the Curb Ramp and Drainage Improvements Project 2004.
