

RESOLUTION NO. 2005-139

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING AN ADJUSTMENT TO THE FY 2005-06 BUDGET FOR THE CITY'S
PARTICIPATION IN THE GREENPRINT PROGRAM BY REDUCING THE GENERAL
FUND IN THE AMOUNT OF \$40,000**

WHEREAS, the City of Elk Grove recognizes that trees are an important aesthetic and biological resource that enhance neighborhood character, provide natural habitat, and improve air quality; and


WHEREAS, the City of Elk Grove currently implements a variety of programs and initiatives to preserve and enhance the City's tree canopy; and

WHEREAS, the Sacramento Tree Foundation has initiated the Greenprint, a regional vision for the importance of trees and the urban forest implemented through a menu of tree preservation and enhancement programs tailored to the unique circumstances of each jurisdiction; and

WHEREAS, the City desires to enter into an initial two year partnership with the Greenprint to design an enhanced tree program tailored to the unique objectives and needs of Elk Grove.


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes an adjustment of the Fiscal Year 2005-06 budget to increase funding for City staff's time on the Greenprint up to \$40,000, with a corresponding reduction of the General Fund.




