BOULEVARD AT STATE ROUTE 99 INTERCHANGE MODIFICATION PROJECT**


WHEREAS, modification of the Elk Grove Boulevard at State Route 99 Interchange will provide for improved public safety and reduced vehicular traffic congestion; and

WHEREAS, the City of Elk Grove requires professional services for preparation of a Project Study Report/Project Report and related preliminary studies for the Elk Grove Boulevard at State Route 99 Interchange Modification Project; and

WHEREAS, key staff at Quincy Engineering, Inc. were directly involved in the design process for the existing Elk Grove Boulevard/State Route 99 interchange and by virtue of its staff's experience with this project, Quincy Engineering, Inc. is uniquely qualified to provide the services required by the City in a timely and cost-effective manner.


