A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER, OR CITY MANAGER'S DESIGNEE, TO EXECUTE REAL ESTATE RELATED CONTRACTS AND DOCUMENTS FOR THE SHELDON ROAD/STATE ROUTE 99 INTERCHANGE RECONSTRUCTION PROJECT

WHEREAS, improving the Sheldon Road/State Route 99 Interchange Reconstruction Project holds a high priority in the City of Elk Grove Transportation Improvement Program and acquiring the necessary right-of-way is an important and necessary step in meeting the goals set forth in the General Plan for the Sheldon Road/State Route 99 Interchange Reconstruction Project; and

WHEREAS, improving the roadways for Sheldon Road, and East and West Stockton Boulevards requires the acquisition of real property interests affecting 45 property owners, as identified on the attached Exhibit 1; and

WHEREAS, the City shall follow the Land Acquisition Procedures as set fort by the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 and its various amendments and the State of California, Department of Housing and Community Development, adopted Title 25 of Chapter 6 of the California Code of Regulation.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager, or his designee, to execute all contracts and documents for the acquisition of right-of-way, relocation expenses, and real property interests for those properties affected by the Sheldon Road/State Route 99 Interchange Reconstruction Project as listed in the attached Exhibit 1, for which the total compensation shall not exceed \$27,400,000.
