

**RESOLUTION NO. 2006-52**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO NEGOTIATE AND  
EXECUTE A CONTRACT WITH MOTOROLA FOR VOICE RADIO CONSOLES FOR  
THE POLICE DEPARTMENT COMMUNICATIONS CENTER, AND AMEND THE  
FISCAL YEAR 2005-06 BUDGET**

**WHEREAS**, on April 27, 2005, the City Council took action to cancel its contract with Sacramento County for law enforcement services, thereby establishing an 18-month timeline to create a municipal police department; and

**WHEREAS**, development of a complete and fully functional Communications Dispatch facility is a necessary component of the police department; and,

**WHEREAS**, effective communication between dispatchers and police officers is important to the success of the police department and to the health and safety of the public; and,

**WHEREAS**, the Motorola console equipment is the only equipment currently supported by the Sacramento Regional Radio Communications System; and,

**WHEREAS**, Motorola is the only vendor that can provide the necessary radio console equipment; and

**WHEREAS**, because no other vendors are able to satisfy the requirements of the Sacramento Regional Radio Communications System or otherwise provide the services that are required, staff recommends that the formal bid process be waived for this purchase.

**WHEREAS**, the Sacramento Regional Radio Communications System also recommends that this equipment be used to support voice communications with the regional communications network; and,

**WHEREAS**, the Police Reserve Budget contains sufficient revenue to be transferred to the General Fund.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove authorizes the City Manager, or his designee, to waive the formal bid process, execute a contract with Motorola in an amount not to exceed \$450,000.00 for the voice radio consoles for the Police Department Communications Center, and amend the Police Department Fiscal year 2005-06 Budget by \$450,000.00 from the Police Reserve Fund.
