

**RESOLUTION NO. 2006-133**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
APPROVING THE CREATION AND ADMINISTRATION OF A POLICE  
DEPARTMENT POLICY MANUAL**

**WHEREAS**, On May 1, 2005, the City Council took action to serve Sacramento County with notice that the City would be terminating its contract for police services and establishing a municipal police department; and

**WHEREAS**, Under the existing contract for police services, the policies for delivery of police services fall under the General Orders of Sacramento County Sheriff. These General Orders will not be in place once termination of the contract with the County occurs; and


**WHEREAS**, The Public Agency Risk Sharing Authority of California (PARSAC) procured the services of Lexipol to assist the City in developing a policy manual; and

**WHEREAS**, a policy manual will be developed consistent with Commission on Accreditation for Law Enforcement Agency (CALEA) standards and in anticipation of a future POST accreditation program; and

**WHEREAS**, new and improved policies will be implemented to reflect changes from precedent setting court decisions, legislation, best practices, and new issues facing public safety agencies.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the Chief of Police to develop and administer a policy manual that addresses the myriad of issues facing public safety organizations, with the input of, and direct consultation with legal, risk management, and public safety professionals.


