**RESOLUTION ESTABLISHING A RESERVE POLICE OFFICER PROGRAM IN
THE ELK GROVE POLICE DEPARTMENT AND AMENDING THE FISCAL
YEAR 2006-2007 POLICE DEPARTMENT BUDGET**

WHEREAS, the Elk Grove Police Department is the primary provider of police services for citizens of the City of Elk Grove; and

WHEREAS In order to maintain efficient delivery of police services for citizens, the department aims to take a proactive role in administering many of its services through the use of a Reserve Police Officer Program; and


WHEREAS, Reserve Police Officers supplement regular personnel and can be used in the event of an emergency, or when manpower is critical; and

WHEREAS, The Department intends to use varying levels of Police Reserves including: Reserve Sergeants, Level I, Level II and Designated Level III Reserve Officers.

NOW THEREFORE, IT BE RESOLVED that the City Council of the City of Elk Grove:

1. Authorizes the establishment of the Elk Grove Police Department Reserve Police Officer Program; and
2. Authorizes the transfer of \$90,000 from General Fund contingency reserve to the police department budget to cover costs for equipment and uniforms related to the Reserve Program; and
3. The City Manager, or his designee shall administer all aspects of the Police Reserve Program; and
4. The Chief of Police shall make recommendations of Reserve Officers and, together, with the City Manager, shall make appointments within the reserve program.



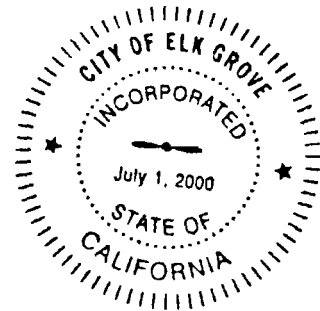
