(FILE NO. 00-062 AND NO. 04-764)**


WHEREAS, Reynen & Bardis (Laguna Ridge) LP has been conditioned to provide certain infrastructure in conjunction with its tentative map within Phase 2 of the Laguna Ridge Specific Plan; and

WHEREAS, the Subdivision Map Act provides that required infrastructure is secured through an improvement agreement if final maps are to be approved and recorded prior to completion and acceptance of the required infrastructure; and

WHEREAS, Reynen & Bardis (Laguna Ridge) LP desires to have final maps approved prior to completion of the required infrastructure.


