

RESOLUTION NO. 2006-316

A RESOLUTION AUTHORIZING THE CITY ENGINEER, OR HIS DESIGNEE, TO EXECUTE THE PROGRAM SUPPLEMENT AND OTHER FUNDING AGREEMENTS WITH CALTRANS FOR THE SAFE ROUTES TO SCHOOL GRANT SECURED BY THE CITY OF ELK GROVE AND AMENDING THE FISCAL YEAR 2006/07 BUDGET

WHEREAS, the California Department of Transportation has approved \$450,000 from the Safe Routes To School Program to the City of Elk Grove; and

WHEREAS, the Safe Routes to School funding will go toward the Laguna Creek Trail project between Ringe Court and Porto Rosa Street and curb extension project on Crowell Drive (between Coliston Drive and Wolloston Way); and

WHEREAS, the disbursement of Safe Routes to School funds for the project requires execution of one or more Program Supplement Agreements or other funding related agreements with the California Department of Transportation; and

WHEREAS, the Caltrans Safe Routes to School funding necessitates an amendment to the Fiscal Year 2006/07 budget.


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer, or his designee, to execute the program supplement agreements with Caltrans for the Safe Routes to School Grant to secure the funds for the City of Elk Grove and approves the Fiscal Year 2006/07 budget amendment to reflect \$450,000 in Caltrans Safe Routes to School funding.




