**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER, OR HIS DESIGNEE TO EXECUTE A
CONTRACT WITH JACKSON CONSTRUCTION FOR THE ELK GROVE
POLICE DEPARTMENT FORENSICS ROOM UPGRADE PROJECT**

WHEREAS, the forensics room needs to be plumbed for a sink and eyewash station, installation of exhaust fan and modification of work areas so forensics evidence can be processed; and

WHEREAS, a critical safety component of processing forensics evidence is the need for a sink and exhaust system for properly disposing chemicals and fumes, and

WHEREAS, competitive bids were solicited and no bids were received,


WHEREAS, another formal bid process for this project would likely have the same results,

WHEREAS, it is in the City's best interest that the work be performed by the contractor with knowledge of the existing structure, and a demonstrated ability to integrate the new construction into the existing facility and is therefore the only reasonable source,

WHEREAS, the fiscal year 2006-07 budget be adjusted by \$35,000 from the Facility Fund.





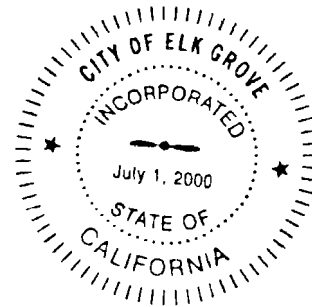
