A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE ADOPTING A MEMORANDUM OF UNDERSTANDING WITH THE SACRAMENTO AREA VEHICLE THEFT REDUCTION UNIT AND AMENDING THE FISCAL YEAR 2007-08 POLICE DEPARTMENT BUDGET BY \$71,000

- WHEREAS, The Elk Grove Police Department provides the full range of public safety programs and enforcement for the City; and
- WHEREAS, In 1991 the Sacramento County Board of Supervisors passed a resolution forming the Sacramento Area Vehicle Theft Reduction Unit (SAVTRU); and
- WHEREAS, California Vehicle Code 9250.14 provides the collection of an annual one dollar (\$1) fee for all vehicles registered in Sacramento County for funding local agency programs that deter, investigate or prosecute vehicle theft crimes; and
- WHEREAS, California Vehicle Code 9250.14 was subsequently amended to collect an additional two dollar (\$2) fee for all commercial motor vehicles registered in a County to fund local agency programs; and
- WHEREAS, A Memorandum of Understanding (MOU) is required between the Elk Grove Police Department and the SAVTRU in order to participate in this program and receive funding, and;
- **WHEREAS**, This provision of Vehicle Code 9250.14, unless reenacted, will expire on January 1, 2010, and;
- WHEREAS, In FY 2007-2008, the Elk Grove Police Department will receive \$71,000 to use in accordance with the terms of the MOU for vehicle theft, investigation, reduction and prevention, and;
- **WHEREAS**, These funds are to be used in support of the Police Department's vehicle theft programs.
- NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Elk Grove:
- 1. That the recitals set forth in this resolution are hereby adopted as true and correct.
 - 2. That the Chief of Police is authorized to execute a Memorandum of Understanding on behalf of the City with the SAVTRU.
 - 3. That the City Manager is hereby authorized and directed to execute budgetary increases in the amount, and subject to the terms, set forth in the recitals to this resolution.
