**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
ACCEPTING THE COMMUNITY DEVELOPMENT BLOCK GRANT BUS STOP  
IMPROVEMENTS PROJECT AS COMPLETE AND AUTHORIZING THE CITY  
ENGINEER TO PREPARE, AND THE CITY CLERK TO FILE, THE NOTICE OF  
COMPLETION WITH THE SACRAMENTO COUNTY RECORDER**

**WHEREAS**, on August 27, 2008, the City Council authorized the award of a construction contract to Biondi Paving Inc. to construct the Community Development Block Grant (CDBG) Bus Stop Improvements Project (Capital Improvements Project ID PF0015) (Project); and

**WHEREAS**, Biondi Paving Inc. has completed the work in accordance with the contract for the Project; and

**WHEREAS**, if no liens or claims have been filed within 35 days of filing the Notice of Completion, retention and any remaining amount due will be released to Biondi Paving Inc.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby accepts the Project as complete.

**BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the CDBG Bus Stop Improvements Project with the Sacramento County Recorder.


