**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE ADOPTING
A VETERAN AND PUBLIC SAFETY STREET NAMING PROGRAM**

WHEREAS, the City Council has expressed a desire to create a citywide program to honor Veterans and Public Safety personnel; and


WHEREAS, the program would include naming new streets after eligible candidates; and

WHEREAS, program criteria and a nomination form have been created along with preferred street sign design layouts.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby adopts a resolution creating a Veteran and Public Safety Street Naming Program which includes:


- 1) Application Packet as outlined in Exhibit A; and

Introduction

The City of Elk Grove's Veteran and Public Safety Street Naming Program is currently accepting nominations of exemplary individuals for possible future street name use. The Program was created to recognize the number of individuals who have served our community and country. By naming a City street in their honour, we hope to promote public awareness of the individual and show our appreciation for their outstanding contributions.

Program Steps

Step 1: **Submit complete nomination form.** Nomination Forms can be found online at www.elkgrovecity.org/streetsign and can be submitted electronically on-line or printed and hand-delivered / mailed to City Hall.

Step 2: **Nomination circulation and review.** The Nomination Form is circulated to the Public Works department for their standard Addressing Guidelines and Improvements Standards Review. To learn more about this review, please visit www.elkgrovecity.org/streetsign.

Step 3: **Decision Letter (approved).** If the Nomination Form has been reviewed by Public Works and is acceptable to be added to the Program Names List, Public Works staff will notify the nominator of the decision.

OR

Decision Letter (not approved). If the Nomination Form has been reviewed by Public Works and is not acceptable to be added to the Program Names List, Public Works will notify the nominator of this decision and why, along with providing information on an appeal process.

Program Criteria

Standing / Status:	Eligible candidates must be deceased, though they need not have died while serving.
Branch of Service:	<p>Eligible military candidates include those having served in Military Departments as defined under Department of Defense Directive 5100.1 which include Departments of the Army, Navy, and Air Force. The Marine Corps is part of the Department of the Navy and upon the declaration of war or when the President directs, the Coast Guard operates under the authority of the Department of the Navy. Eligible candidates must also be considered Veterans.</p> <p>Eligible candidates also include individuals of earlier communities who served the greater Elk Grove area and immigrants to Elk Grove who served in the armed forces of allied nations during wartime.</p> <p>Eligible Public Safety personnel include Police Officer and Fire Fighter candidates that served in Elk Grove as well as personnel who died in the line of duty.</p>
Level of Service:	Eligible military candidates must have been honorably discharged. Police or Fire personnel may not have been terminated for cause from employment.
Relationship to Elk Grove:	<p>Eligible military candidates must have once resided in Elk Grove, as it is now known or was considered Elk Grove during the candidate's lifetime.</p> <p>Eligible Police Officer and Fire Fighter candidates must have served in Elk Grove, regardless of whether they lived in Elk Grove or died while in the line of duty.</p>
Nomination:	Family members must not object to nominations of their eligible relatives. Any family member objection issued prior to the naming of a street in honor of someone will invalidate their Nomination Form.
Verification:	Documentary proof of a candidate's service must accompany the Nomination Form. Proof may come in a variety of forms, but should be verifiable without requiring an excessive amount of staff time. The DD Form 214 (Report of Separation) is the City's preferred documentation for military candidates. Before January 1, 1950, several similar forms were used by the military services, including the WD AGO 53, WD AGO 55, WD AGO 53-55, NAVPERS 553, NAVMC 78PD, and the NAVCG 553.

Eligible candidates must meet all listed Program Criteria as well as undergo the City's standard Addressing Guidelines and Improvements Standards Review.

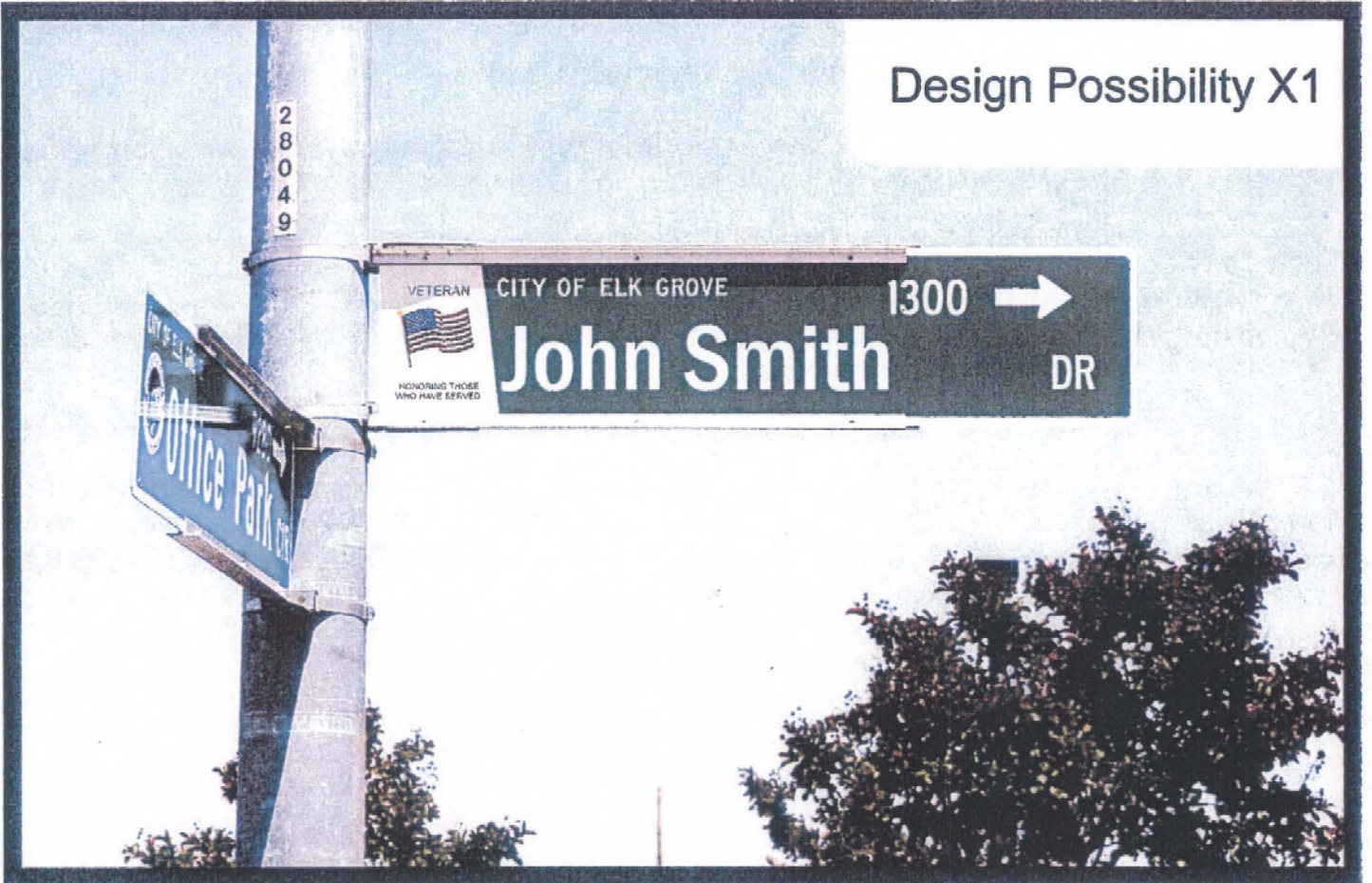

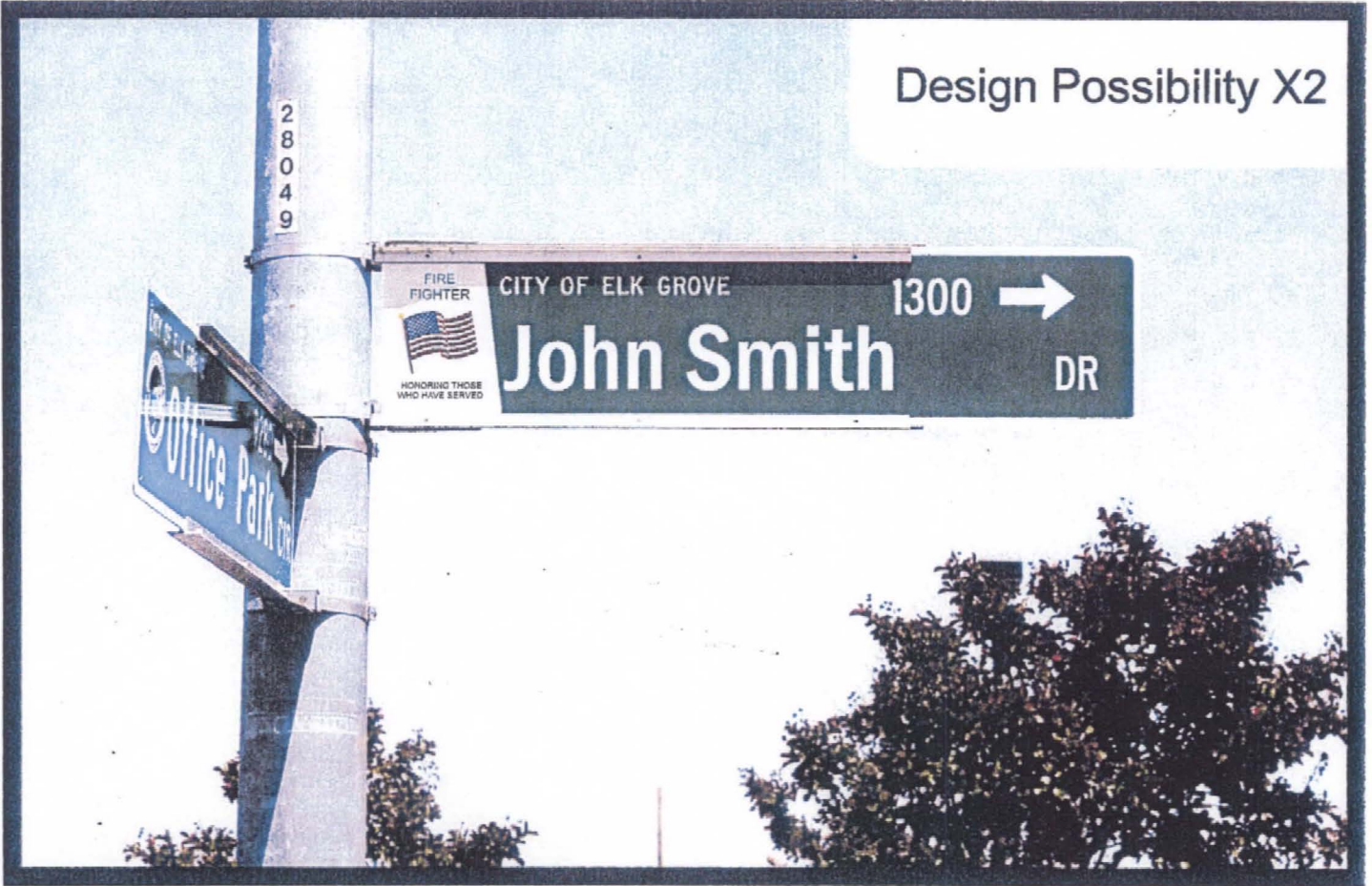

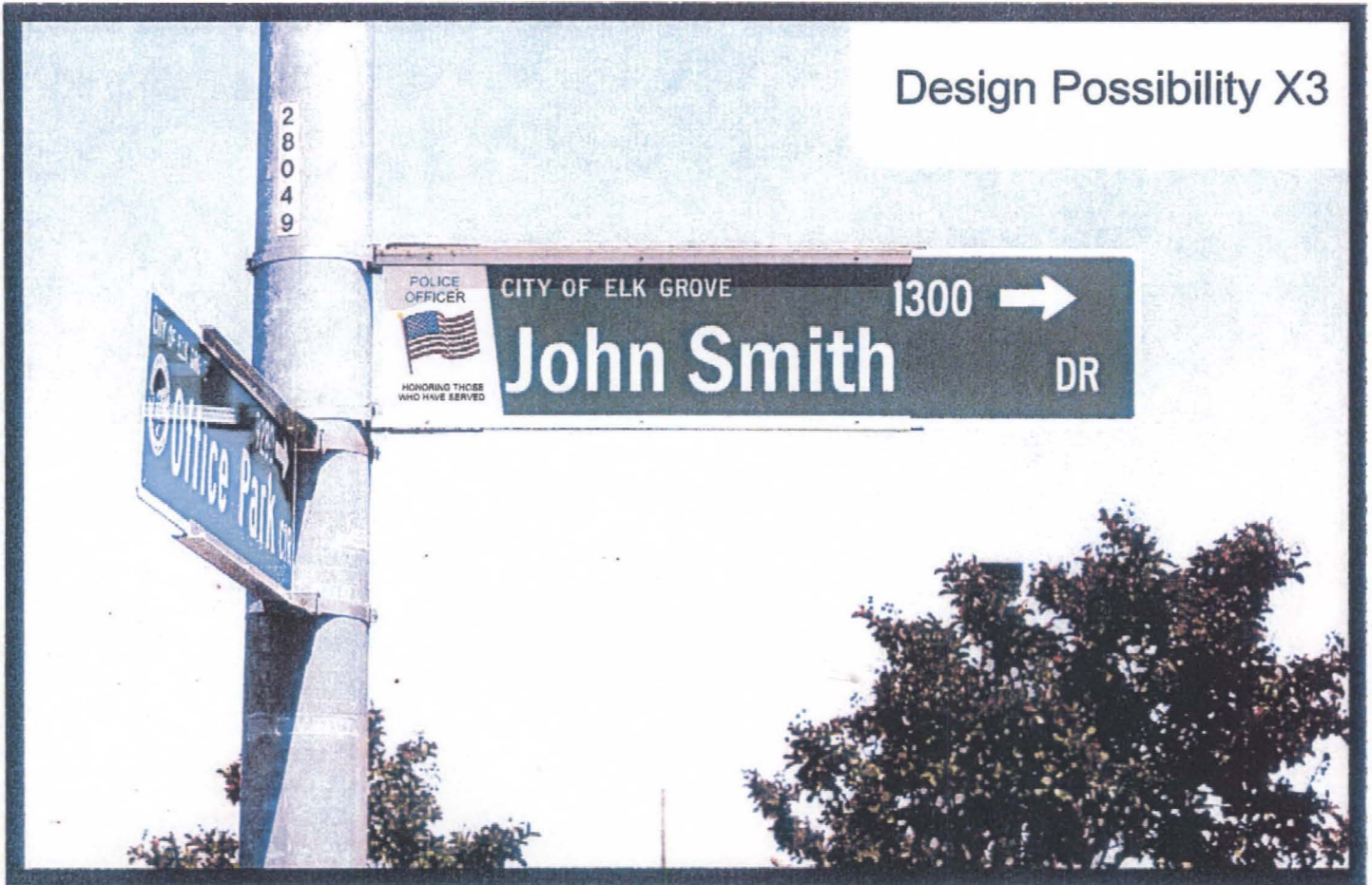
