RESOLUTION NO. 2008-48

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE TO AMEND THE 2007-2012 CAPITAL IMPROVEMENT PROGRAM AND THE FISCAL YEAR 2007-08 BUDGET BY APPROVING THE ALLOCATION OF \$2,198,275 OF PROPOSITION 1B FUNDS FOR THE ANNUAL PAVEMENT RESURFACING PROGRAM

WHEREAS, Proposition 1B Funds–Transportation Bond (1B Funds) were earmarked in the City Council adopted 2007-2012 Capital Improvement Program as anticipated revenue starting in Fiscal Year 2009-10;

WHEREAS, \$2,198,275 of the 1B Funds allocated to the City of Elk Grove are now available in Fiscal Year 2007-08, two years earlier than anticipated; and

WHEREAS, to receive the 1B Funds from the State Department of Finance (DOF), the following actions are required by the City:

- 1. 1B Funds must be in the City's adopted budget for Fiscal Year 2007-08; and
- 2. Projects should be identified and incorporated within the adopted 2007-2012 Capital Improvement Program.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby amends the Fiscal Year 2007-08 budget for the Annual Pavement Resurfacing Program to include \$2,198,275 of Proposition 1B Funds and amends the 2007-2012 Capital Improvement Program to reflect the 1B Funds in the Annual Pavement Resurfacing Program, as identified on Exhibit A, attached hereto and incorporated herein by reference.
