

**RESOLUTION NO. 2008-115**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY ENGINEER TO EXECUTE A CHANGE ORDER NOT TO  
EXCEED \$45,000 TO THE CONSTRUCTION CONTRACT WITH HEDMAN DRILLING  
FOR THE DESTRUCTION OF DOMESTIC WATER WELLS ON THE SHELDON  
ROAD/STATE ROUTE 99 INTERCHANGE RECONSTRUCTION PROJECT**

**WHEREAS**, the construction of the Sheldon Road / State Route 99 Interchange Reconstruction Project (Capital Improvement Project ID PT0010) required advance site preparation work including destruction of domestic water wells and related work; and

**WHEREAS**, Hedman Drilling was the selected low bidder and awarded a construction contract on July 7, 2007; and

**WHEREAS**, additional water wells and the need for related work have been discovered; and


**WHEREAS**, a change order is required in the amount of \$45,000; and

**WHEREAS**, approval of the change order would increase the contracted amount from \$108,000 to \$153,000; and

**WHEREAS**, there are sufficient funds in the adopted Fiscal Year 2007-08 Budget and 2007-2012 Capital Improvement Program to accommodate the change order through Measure A funds.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to execute a change order not to exceed \$45,000 to the construction contract with Hedman Drilling for the destruction of water wells on the Sheldon Road/State Route 99 Interchange Reconstruction Project.


