**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSULTANT CONTRACT  
AMENDMENT IN AN AMOUNT NOT TO EXCEED \$3,927,000 WITH MCE  
CORPORATION FOR THE OPERATION AND MAINTENANCE OF THE CITY'S  
STREETS AND DRAINAGE FACILITIES  
FROM JULY 1, 2008 THROUGH JUNE 30, 2009**


**WHEREAS**, the City of Elk Grove desires to continue maintaining its street and drainage facilities during Fiscal Year 2008-09; and

**WHEREAS**, MCE Corporation is qualified and capable of continuing their services in providing operations and maintenance to the City; and

**WHEREAS**, the existing agreement between the City of Elk Grove and MCE Corporation term can be extended by amendment for services through June 30, 2009 for an amount not to exceed \$3,927,000.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute an amendment in an amount not to exceed \$3,927,000 to the existing contract between the City of Elk Grove and MCE Corporation for Operations and Maintenance of the City's streets and drainage facilities from July 1, 2008 through June 30, 2009.
