

**RESOLUTION NO. 2008-198**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION  
CONTRACT IN THE AMOUNT OF \$159,840.90 WITH BIONDI PAVING FOR THE  
COMMUNITY DEVELOPMENT BLOCK GRANT BUS STOP IMPROVEMENTS  
PROJECT AND AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE  
ORDERS NOT TO EXCEED THE CONTINGENCY AMOUNT OF \$23,976.13**

**WHEREAS**, as part of the City of Elk Grove's effort to improve accessibility, nine (9) bus stop locations throughout the City are proposed to be improved to meet current Americans with Disabilities Act standards; and

**WHEREAS**, the Community Development Block Grant (CDBG) Bus Stop Improvements Project is included in the approved 2008-2013 Capital Improvement Program and is budgeted within the approved Fiscal Year 2008-09 budget; and


**WHEREAS**, an invitation to bid was duly advertised on June 18, 2008, bids were opened on July 22, 2008, and Biondi Paving was determined to be the responsible bidder submitting the lowest responsive bid.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Elk Grove that the Community Development Block Grant Bus Stop Improvements Project is exempt under California Environmental Quality Act Categorical Exemption Class 1 – Existing Facilities and no further environmental review is required.

**BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby:

1. Authorizes the City Manager to execute a construction contract with Biondi Paving in the amount of \$159,840.90 for the CDBG Bus Stop Improvements Project; and
2. Authorizes the City Engineer to approve change orders not to exceed the contingency amount of \$23,976.13


