**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
ACCEPTING THE FRANKLIN BOULEVARD / PERCHERON DRIVE AND FRANKLIN  
BOULEVARD / BLOSSOM RIDGE DRIVE SIGNAL UPGRADE PROJECT AS  
COMPLETE AND AUTHORIZING THE CITY ENGINEER TO PREPARE A NOTICE  
OF COMPLETION AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION  
WITH THE SACRAMENTO COUNTY RECORDER**

**WHEREAS**, on March 26, 2008, the City Council authorized the award of a construction contract to Republic Intelligent Transportation Systems (ITS), Inc. to construct the Franklin Boulevard / Percheron Drive and Franklin Boulevard / Blossom Ridge Drive Signal Upgrade Project (Capital Improvements Project ID PT0079); and

**WHEREAS**, the Project included salvaging existing equipment, furnishing and installing new poles and mast arms with hardware; and

**WHEREAS**, Republic ITS, Inc. has completed the work in accordance with the contract for the Project; and

**WHEREAS**, if no liens or claims have been filed within 35 days of filing the Notice of Completion, retention and any remaining amount due will be released to Republic ITS, Inc.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby accepts the Franklin Boulevard / Percheron Drive and Franklin Boulevard / Blossom Ridge Drive Signal Upgrade Project as complete.

**BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Franklin Boulevard / Percheron Drive and Franklin Boulevard / Blossom Ridge Drive Signal Upgrade Project with the Sacramento County Recorder.


