

**RESOLUTION NO. 2009-50**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSULTANT SERVICES  
CONTRACT AMENDMENT WITH MARK THOMAS & COMPANY, INC. FOR THE  
GRANT LINE ROAD / STATE ROUTE 99 INTERCHANGE RECONSTRUCTION  
PROJECT EXTENDING THE TERMINATION DATE TO JANUARY 31, 2010**

**WHEREAS**, the City of Elk Grove desires to reconstruct the Grant Line Road / State Route 99 Interchange Reconstruction Project (Capital Improvement Project ID PT0009) (Project); and

**WHEREAS**, the reconstructed interchange is fully operational; however, the landscape contract has not yet been awarded; and

**WHEREAS**, the landscape contract will be awarded this spring with landscape completion expected in the fall of 2009; and

**WHEREAS**, consultant bidding assistance and construction support is required for the landscape portion of the Project; and

**WHEREAS**, the current consultant services contract with Mark Thomas & Company, Inc. (Mark Thomas) for preparation of construction documents and related engineering support for the Project was executed on August 24, 2004 and will expire March 31, 2009; and

**WHEREAS**, the new extended termination date of January 31, 2010 will enable Mark Thomas to continue to provide necessary services for the Project including bidding assistance and construction support for the landscaping contract.


**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a consultant services contract amendment, attached hereto and incorporated herein, with Mark Thomas & Company, Inc. for the Grant Line Road / State Route 99 Interchange Reconstruction Project to extend the termination date to January 31, 2010.




