

**RESOLUTION NO. 2009-60**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING AND RATIFYING EXPENDITURE OF FUNDS TO PACIFIC GAS AND  
ELECTRIC FOR COMPRESSED NATURAL GAS FOR TRANSIT BUSES IN AN  
AMOUNT NOT TO EXCEED \$80,000 AND REVISING RESOLUTION NO. 2008-146**

**WHEREAS**, the City's Transit Division utilizes Compressed Natural Gas (CNG) buses and needs to purchase CNG fuel to operate the fleet; and

**WHEREAS**, on June 25, 2008 the City Council adopted Resolution No. 2008-146 authorizing the City Manager to purchase CNG fuel from five vendors: Regional Transit, in an amount not to exceed \$200,000; Pacific Gas and Electric (PG&E), in an amount not to exceed \$300,000; Elk Grove Unified School District, in an amount not to exceed \$30,000; Lodi Unified School District, in an amount not to exceed \$15,000; and the City of Lodi, in an amount not to exceed \$100,000; and

**WHEREAS**, the City has purchased significantly more CNG fuel from Pacific Gas and Electric for the Fiscal Year 2008-09 than the amounts stated in Resolution 2008-146 because that has been the most efficient fueling option; and

**WHEREAS**, the City has incurred an amount not to exceed \$80,000 in expenses relating to purchasing fuel from Pacific Gas and Electric during Fiscal Year 2008-09; and

**WHEREAS**, these expenditures are included in the Transit Division's Fiscal Year 2008-09 budget, but the amount expended with PG&E requires Council authorization and ratification.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby ratifies and authorizes the City Manager to pay the total unpaid expenditures for CNG fuel to Pacific Gas and Electric in an amount not to exceed \$80,000.

**NOW, THEREFORE, BE IT FURTHER RESOLVED** that the City Council hereby removes the vendor expenditure limits established in Resolution No. 2008-146.


