

RESOLUTION NO. 2009-80

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION
CONTRACT WITH GEORGE REED, INC. FOR THE ELK GROVE BOULEVARD
REHABILITATION PROJECT (FRANKLIN BOULEVARD TO BRUCEVILLE ROAD) IN
THE AMOUNT OF \$1,168,616.39 AND AUTHORIZING THE CITY ENGINEER TO
APPROVE CHANGE ORDERS NOT TO EXCEED \$175,292**

WHEREAS, as part of the City of Elk Grove's (City) Pavement Maintenance Program, the City performs various surface treatments throughout the City to maintain the quality of its streets; and

WHEREAS, the Elk Grove Boulevard Rehabilitation Project Franklin Boulevard to Bruceville Road (Capital Improvement Project ID PT0068) (Project) is included in the approved 2008-13 Capital Improvement Program and is budgeted within the approved Fiscal Year 2008-09 budget; and

WHEREAS, an invitation to bid was duly advertised on February 25, 2009, bids were opened on March 17, 2009, and George Reed, Inc. was determined to be the lowest responsible bidder submitting the lowest responsive bid.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Authorizes the City Manager to execute a construction contract with George Reed, Inc. for the Elk Grove Boulevard Rehabilitation Project (Franklin Boulevard to Bruceville Road) in the amount of \$1,168,616.39 upon receipt of all required bonds and insurance and the approval of such bonds and insurance by the City Attorney and the Risk Manager; and
- 2) Authorizes the City Engineer to approve change orders not to exceed \$175,292.


