

RESOLUTION NO. 2009-172

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A TASK ORDER
WITH MARK THOMAS AND COMPANY, INC. FOR ENGINEERING SERVICES
FOR LANDSCAPING AT GRANT LINE ROAD / STATE ROUTE 99 AND
SHELDON ROAD / STATE ROUTE 99 INTERCHANGES
IN AN AMOUNT NOT TO EXCEED \$82,227**

WHEREAS, the City has prepared landscaping plans for the Sheldon and Grant Line interchanges; and

WHEREAS, there are additional engineering services required for these landscaping plans; and

WHEREAS, the services are required to incorporate entry signs, incorporate larger size oak trees, and combine the two projects into a single construction bid document; and

WHEREAS, staff has solicited and received fee proposals from several of its on-call engineering consultants to provide design services for the necessary revisions to landscaping plans; and

WHEREAS, based upon evaluation of proposals received, the City has determined that Mark Thomas and Company, Inc. is the most qualified of these firms based upon its demonstrated ability, knowledge of the project and landscape architect firm, and Caltrans permitting procedures; and

WHEREAS, the aforementioned contract with Mark Thomas and Company, Inc. enables the City of Elk Grove to request work covered under the scope of the contract by means of a task order.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a task order with Mark Thomas and Company, Inc. for professional engineering services for the Sheldon Road and Grant Line Road interchanges in an amount not to exceed \$82,227.
