

RESOLUTION NO. 2010-36

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO ACCEPT GRANT FUNDING FROM THE
CALIFORNIA OFFICE OF TRAFFIC SAFETY AND AMEND THE POLICE
DEPARTMENT 2010 FISCAL YEAR BUDGET TO APPROPRIATE GRANT FUNDS IN
THE AMOUNT OF \$7,500 FOR THE PURPOSE OF REDUCING UNDERAGE
DRINKING IN ELK GROVE**

WHEREAS, in December 2009, the Office of Traffic Safety announced funding opportunities for local law enforcement agencies interested in implementing *Minor Decoy* and *Shoulder Tap* operations; and

WHEREAS, the Office of Traffic Safety has awarded the Elk Grove Police Department a grant in the amount of \$7,500 to implement programs to reduce underage drinking; and

WHEREAS, the safety of Elk Grove citizens is the Police Department's primary concern; and

WHEREAS, these grant funds will allow the Police Department to work additional hours to implement the *Minor Decoy* and *Shoulder Tap* operations throughout the City of Elk Grove; and

WHEREAS, this grant supports City Council's goal to grow and support safe, livable, attractive neighborhoods.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Accepts a grant award from the California Office of Traffic Safety in the amount of \$7,500; and
- 2) Authorizes the City Manager to execute all related award documents required for receiving such funds pursuant to the terms and conditions of the Office of Traffic Safety; and
- 3) Amends the Police Department's revenue and expense budgets as follows:




