

**RESOLUTION NO. 2010-57**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSULTANT  
SERVICES CONTRACT AMENDMENT WITH PB AMERICAS, INC. FOR  
CONSTRUCTION MANAGEMENT SERVICES FOR THE SHELDON ROAD / STATE  
ROUTE 99 INTERCHANGE RECONSTRUCTION PROJECT TO EXTEND THE TERM  
OF THE CONTRACT THROUGH DECEMBER 31, 2010 AND INCREASE THE  
CONTRACT AMOUNT BY \$217,442**

**WHEREAS**, the City of Elk Grove and PB Americas, Inc. (PB Americas) entered into a contract for the Sheldon Road / State Route 99 Interchange Reconstruction Project on October 26, 2007 (Contract No. C-07-467); and

**WHEREAS**, construction activities which were expected to be completed in December 2009 will now be completed in early summer 2010 primarily due to unanticipated pavement raveling; and

**WHEREAS**, the City requires additional construction management services to be provided under this amendment and this necessitates an increase to the contract amount by \$217,442; and

**WHEREAS**, this budget-related contract amendment can be accommodated within the approved project budget; and

**WHEREAS**, the contract is scheduled to expire on July 31, 2010 and will also need to be amended to extend the term through December 31, 2010.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a consultant services contract amendment with PB Americas, Inc. for construction management services for the Sheldon Road / State Route 99 Interchange Reconstruction Project to extend the term of the contract through December 31, 2010 and increase the contract amount by \$217,442 resulting in a total not-to-exceed contract amount of \$2,849,044.


