A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION CONTRACT WITH DESILVA GATES CONSTRUCTION FOR THE FRANKLIN BOULEVARD / ELK GROVE BOULEVARD INTERSECTION AND BUS TURNOUTS WIDENING PROJECT IN THE AMOUNT OF \$1,005,666 AND AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE ORDERS NOT TO EXCEED \$151,000

WHEREAS, the Franklin Boulevard / Elk Grove Boulevard Intersection Widening and Bus Turnouts Project is included in the approved 2009-14 Capital Improvement Program and is budgeted within the approved Fiscal Year 2009-10 Budget; and

WHEREAS, On January 13, 2010, the Elk Grove City Council certified the amended Final Initial Study / Mitigated Negative Declaration for the Project, pursuant to the California Environmental Quality Act; and

WHEREAS, an invitation to bid was duly advertised on February 24, 2010, bids were opened on March 17, 2010, and DeSilva Gates Construction was determined to be the lowest responsible bidder submitting the lowest responsive bid.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Authorizes the City Manager to execute a construction contract with DeSilva Gates Construction for the Franklin Boulevard / Elk Grove Boulevard Intersection Widening and Bus Turnouts Project in the amount of \$1,005,666; and
- 2) Authorizes the City Engineer to approve change orders not to exceed \$151,000.
