A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE **AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSULTANT** CONTRACT AMENDMENT WITH WOOD RODGERS. INC. FOR THE FRANKLIN **BOULEVARD / ELK GROVE BOULEVARD INTERSECTION WIDENING AND BUS** TURNOUTS PROJECT IN THE AMOUNT OF \$12,270 FOR A TOTAL **COMPENSATION AMOUNT NOT TO EXCEED \$713,363** 

WHEREAS, the City of Elk Grove and Wood Rodgers, Inc. (Wood Rodgers) entered into a consultant services contract for the Franklin Boulevard / Elk Grove Boulevard Intersection Widening and Bus Turnouts Project on October 20. 2004 (Contract No. C-04-167); and

WHEREAS, additional professional services are required of Wood Rodgers to coordinate with outside agencies and develop exhibits and Wood Rodgers has agreed to provide these services for an amount not to exceed \$12,270; and

WHEREAS, the amendment would increase the total compensation allowed under the consultant contract from \$701,093 to \$713,363 and can be accommodated within the current approved project budget.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a consultant contract amendment with Wood Rodgers, Inc. for the Franklin Boulevard / Elk Grove Boulevard Intersection Widening and Bus Turnouts Project in the amount of \$12,270 for a total compensation amount not to exceed \$713,363.
