

**RESOLUTION NO. 2010-66**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A TASK ORDER WITH  
MARK THOMAS AND COMPANY, INC. FOR ENGINEERING SERVICES FOR  
THE LONG LEAF DRIVE BRIDGE OVER ELK GROVE CREEK PROJECT  
IN AN AMOUNT NOT TO EXCEED \$135,958**

**WHEREAS**, the City has identified the need for a bridge to connect the future extension of Long Leaf Drive and the new Sutter Elk Grove Medical Plaza to Laguna Springs Drive and the Laguna Springs Corporate Centers; and

**WHEREAS**, engineering services are required to select a bridge type and support environmental documentation and permitting; and

**WHEREAS**, staff has solicited and received fee proposals from several of its on-call engineering consultants to provide design services for the project; and

**WHEREAS**, based upon evaluation of proposals received, the City has determined that Mark Thomas and Company, Inc. is the best qualified of these firms based upon its demonstrated ability, relevant experience in designing bridges, knowledge of the project, and knowledge of the environmental documentation and permitting requirements; and

**WHEREAS**, the aforementioned on-call contract with Mark Thomas and Company, Inc. enables the City of Elk Grove to request work covered under the scope of the contract by means of a task order.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a task order with Mark Thomas and Company, Inc. for professional engineering services for the Long Leaf Drive Bridge over Elk Grove Creek Project in an amount not to exceed \$135,958.


