A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION CONTRACT WITH WUNSCHEL & SONS, INC. FOR THE STONEBROOK DRIVE PEDESTRIAN / BICYCLE TRAIL IMPROVEMENT PROJECT IN THE AMOUNT OF \$19,970 AND AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE ORDERS NOT TO EXCEED \$4,000

- 1) Finds that the project is exempt from environmental review under the California Environmental Quality Act (CEQA) pursuant to CEQA guidelines Section 15301 (c) and (f); and
- 2) Authorizes the City Manager to execute a construction contract with Wunschel & Sons, Inc. for the Stonebrook Drive Pedestrian / Bicycle Trail Improvement Project in the amount of \$19,970; and
- 3) Authorizes the City Engineer to approve change orders not to exceed \$4,000.
