WHEREAS, on May 13, 2009, the City Council authorized the award of a construction contract to Top Grade Construction, Inc. to construct the Asphalt Concrete Overlay and Curb Ramp Improvements Project 2009 (Capital Improvement Project ID PT3509 and PT5809 respectively) and Elk Grove Boulevard Rehabilitation (Bruceville to State Route 99) Project (Capital Improvement Project ID PT0096) (Projects); and

WHEREAS, as part of the City of Elk Grove's Pavement Resurfacing Program, the Project provided asphalt concrete overlay, pavement restoration, curb ramp improvements, and new traffic striping and traffic signal modifications; and

WHEREAS, Top Grade Construction, Inc. has completed the work in accordance with the contract documents for the Project; and

WHEREAS, if no liens or claims have been filed within 35 days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Top Grade Construction, Inc.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Project as complete.

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.
