A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION CONTRACT WITH GATEWAY PACIFIC CONTRACTORS, INC. FOR THE GRANT LINE CHANNEL RESTORATION PROJECT IN THE AMOUNT OF \$645,618 AND AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE ORDERS **NOT TO EXCEED \$100,000** 

WHEREAS, the Grant Line Channel Restoration Project (Project) is budgeted within the approved Fiscal Year 2009-10 Budget; and

WHEREAS, an invitation to bid was duly advertised on March 17, 2010, a mandatory pre-bid meeting was held on March 25, 2010, bids were opened on April 1, 2010, and Gateway Pacific Contractors, Inc. was determined to be the lowest responsible bidder submitting the lowest responsive bid.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Finds that the Project is exempt from review under the California Environmental Quality Act (CEQA) pursuant to Section 15301(d) of Title 14 of the California Code of Regulations; and
- 2) Authorizes the City Manager to execute a construction contract with Gateway Pacific Contractors, Inc. for the Grant Line Channel Restoration Project in the amount of \$645,618; and
- 3) Authorizes the City Engineer to approve change orders for an amount not to exceed \$100,000.
