A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE APPROVING THE TREE PLANTING AND LANDSCAPING APPLICATION FOR GRANT FUNDS FOR THE URBAN GREENING GRANT PROGRAM UNDER THE SAFE DRINKING WATER, WATER QUALITY AND SUPPLY, FLOOD CONTROL, RIVER AND COASTAL PROTECTION BOND ACT OF 2006 (PROPOSITION 84)

WHEREAS, the Legislature and Governor of the State of California have provided funds for Proposition 84; and

WHEREAS, the official title of Proposition 84 is the Water Quality, Safety, and Supply, Flood Control, Natural Resource Protection, Park Improvements Bond Act and it is also commonly known as the Safe Drinking Water, Water Quality and Supply, Flood Control, River and Coastal Protection Bond Act; and

WHEREAS, the Strategic Growth Council has been delegated the responsibility by the State of California for the administration of this grant program and establishing necessary procedures; and

WHEREAS, procedures established by the Strategic Growth Council require a resolution certifying the approval of application(s) by the applicant's governing board before submission of application(s) to the State; and

WHEREAS, the proposed Tree Planting and Landscaping Project will plant trees and landscape areas in the City of Elk Grove; and

WHEREAS, the City of Elk Grove, if selected, will enter into an agreement with the State of California to carry out the proposed project.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Approves the filing of an application for the Tree Planting and Landscaping Project; and
- Certifies the City understands the funding guidelines and certification in the application; and
- Certifies the Citywill have sufficient funds to operate and maintain the project consistent with the land tenure requirements or will secure the resources to do so; and
- 4) Certifies that it will comply with the provisions of Section 1771.8 of the State Labor Code regarding payment of prevailing wages on Projects awarded Proposition 50 Funds; and

- 5) If applicable, certifies that the project will comply with any laws and regulations including, but not limited to, legal requirements for building codes, health and safety codes, disabled access laws, environmental laws and, that prior to commencement of construction, all applicable permits shall be obtained; and
- 6) Certifies that applicant will work towards the Governor's State Planning Priorities intended to promote equity, strengthen the economy, protect the environment, and promote public health and safety as included in Government Code Section 65041.1; and
- 7) Appoints the Public Works Director, or designee, as the agent to conduct all negotiations, execute and submit all documents including, but not limited to, applications, agreements, payment requests and so on, which may be necessary for the completion of the aforementioned project.
