A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AMENDING THE 2009-14 CAPITAL IMPROVEMENT PROGRAM AND THE FISCAL YEAR 2009-10 BUDGET BY APPROVING THE ALLOCATION OF AN ADDITIONAL \$55,000 IN ELK GROVE ROADWAY FEE FUNDING FOR THE ELK GROVE-FLORIN ROAD / BROWN ROAD-SILVERBERRY AVENUE TRAFFIC SIGNAL AND INTERSECTION IMPROVEMENT PROJECT

WHEREAS, the Elk Grove-Florin Road / Brown Road-Silverberry Avenue Traffic Signal and Intersection Improvement Project (Capital Improvement Project ID PT0091) is identified as an eligible project in the nexus study for the Elk Grove Roadway Fee Program, which was approved by the City Council on July 8, 2009; and

WHEREAS, the project budget has increased from \$330,000 to \$385,000, an increase of \$55,000 that is needed from the Elk Grove Roadway Fee Program; and

WHEREAS, the cost increases are due to the unforeseen need to incorporate additional improvements to upgrade curb ramps and sidewalk to be compliant with Americans with Disabilities Act standards and installing a bus pad and related modifications to existing landscaping; and

WHEREAS, the additional scope of work has resulted in increases in preliminary engineering and construction engineering costs; and

WHEREAS, the project budget also did not account for City-furnished signal controller cabinet costs; and

WHEREAS, a budget amendment in the amount of \$55,000 from the Elk Grove Roadway Fee Program is necessary to augment the current budget.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby amends the 2009-14 Capital Improvement Program and the Fiscal Year 2009-10 Budget by increasing the project budget from \$330,000 to \$385,000, allocating an additional \$55,000 in Elk Grove Roadway Fee funding to the Elk Grove-Florin Road / Brown Road-Silverberry Avenue Traffic Signal and Intersection Improvement Project.
