A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
APPROVING AN AGREEMENT FOR MAINTENANCE OF JOINT TRANSPORTATION

AGREEMENT AND AUTHORIZING THE CITY ENGINEER TO APPROVE
MUTUALLY AGREED REVISIONS WITHIN HIS SPENDING AUTHORITY

WHEREAS, the City of Elk Grove (COEG) desires to enter into an agreement with the City of Sacramento (COSAC) to identify and establish the respective maintenance responsibilities associated with joint transportation facilities; and

WHEREAS, an agreement has been negotiated and drafted by COEG and COSAC staff that delineates the respective responsibilities of the COEG and the COSAC to perform and/or fund maintenance activities associated with the shared transportation facilities, including pavement and roadside maintenance, tree and landscape maintenance, traffic signs, striping and markings, traffic signal operations, hazardous materials response, emergency response during both after and regular work hours.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Approves the agreement for maintenance of joint transportation facilities between the City of Elk Grove and the City of Sacramento; and
- 2) Authorizes the City Manager to execute the agreement; and
- 3) Authorizes the City Engineer to approve mutually agreed revisions within his spending authority.
