A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO ACCEPT GRANT FUNDING FROM THE SACRAMENTO COUNTY OFFICE OF EMERGENCY SERVICES FOR EMERGENCY PREPAREDNESS EQUIPMENT IN THE AMOUNT OF \$37,133 AND AMEND THE FISCAL YEAR 2010-11 BUDGET

WHEREAS, the Sacramento County Office of Emergency Services administers the State Homeland Security Grant Program; and

WHEREAS, the Elk Grove Police Department requested funding in the amount of \$37,133 to purchase emergency preparedness equipment; and

WHEREAS, the Elk Grove Police Department's proposal for emergency preparedness equipment was selected by the Sacramento County Office of Emergency Services for funding; and

WHEREAS, there is sufficient funding in the Police Department's budget to satisfy a grant match in the amount of \$4,945; and

WHEREAS, Sacramento County requires that the City's governing body approve acceptance of grant funds by Resolution.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to: 1) accept an appropriation from Sacramento County Office of Emergency Services in the amount of \$37,133; and 2) increase the Police Department's revenue and expense budget in the amount of \$37,133.
