A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE CONSULTANT SERVICES CONTRACT AMENDMENTS WITH DAVID FORD CONSULTING ENGINEERS, KIMLEY-HORN AND ASSOCIATES, MARK THOMAS AND COMPANY, NOLTE ASSOCIATES, TRS CONSULTANTS, AND WEST YOST AND ASSOCIATES TO EXTEND THE TERMINATION DATE FOR ON-CALL ENGINEERING SERVICES

- WHEREAS, utilizing on-call consultant contracts enables the City to engage professional engineering resources quickly and efficiently by eliminating the need for a formal consultant selection process for selected types of work; and
- WHEREAS, in October 2005, staff issued a Request for Qualifications for engineering firms to provide general engineering services on an as-needed basis and staff determined through a competitive selection process that David Ford Consulting Engineers, Kimley–Horn and Associates, Mark Thomas and Company, Nolte Associates, TRS Consultants, and West Yost and Associates were best qualified to carry out the engineering services requested; and
- WHEREAS, the original consultant services contracts with the firms listed above were approved by City Council on May 10, 2006 for an amount not-to-exceed \$750,000 annually; and
- WHEREAS, on June 11, 2008, the terms of each contract were amended extending the termination dates from June 30, 2008 to June 30, 2010; and
- WHEREAS, as a minimum, the proposed amendments will extend the term of each contract for sufficient time to allow task orders to be completed that would otherwise not be completed before the current scheduled contract termination date; and
- **WHEREAS**, the term of each on-call contract is proposed to be extended to the dates listed in Exhibit A to this resolution.
- NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute amendments to the existing consultant services contracts with David Ford Consulting Engineers, Kimley-Horn and Associates, Mark Thomas and Company, Nolte Associates, TRS Consultants, and West Yost and Associates to extend the termination date for each contract as shown in Exhibit A to this resolution.
