A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE **AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH THE** COUNTY OF SACRAMENTO IN AN AMOUNT NOT TO EXCEED \$66,000 FOR ACCESS TO THE CALIFORNIA LAW ENFORCEMENT TELECOMMUNICATIONS SYSTEM AND THE CALIFORNIA JUSTICE INFORMATION SYSTEM APPLICATIONS AND AUTHORIZING THE CITY MANAGER TO EXECUTE ANNUAL CONTRACT RENEWALS WHICH DO NOT EXCEED \$75,000 EACH YEAR

WHEREAS, Sacramento County and the Office of Communications and maintain the California Information Technology (OCIT) Law Telecommunications System (CLETS) and Criminal Justice Information System (CJIS) applications and administer access rights to local police agencies; and

WHEREAS, full access to the CLETS and CJIS is essential to the routine tasks of police personnel; and

WHEREAS, access to the CLETS and CJIS applications requires an access agreement (Exhibit A), memorandum of understanding (Exhibit B), and user fees; and

WHEREAS, Elk Grove Municipal Code Section 3.42.180(B)(2) exempts this expenditure from the competitive bidding process as Sacramento County is the sole source provider of these services; and

WHEREAS, there is sufficient funding in the Police Department's Fiscal Year 2010-11 budget for user fees associated with access to the CLETS and CJIS applications.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove authorizes the City Manager to: 1) execute an agreement with the County of Sacramento in an amount not to exceed \$66,000 for access to the California Law Enforcement Telecommunications System (CLETS) and California Justice Information System (CJIS) applications, and 2) execute annual contract renewals which do not exceed \$75,000 each year.
