

**RESOLUTION NO. 2010-135**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
APPROVING THE APPLICATION SUBMITTAL OF THE USED OIL  
PAYMENT PROGRAM THROUGH CALRECYCLE**

**WHEREAS**, Public Resources Code sections 48690, et seq., authorize the California Department of Resources Recycling and Recovery ("CalRecycle"), formerly known as the California Integrated Waste Management Board, to make payments to qualifying jurisdictions for implementation of their Used Oil Program as required by Public Resources Code sections 48690, et seq.; and

**WHEREAS**, in furtherance of this authority, CalRecycle is required to establish procedures governing the administration of the Used Oil Payment Program; and

**WHEREAS**, CalRecycle's procedures for administering the Used Oil Payment Program require, among other things, an applicant's governing body to declare by resolution certain authorizations related to the administration of the Used Oil Payment Program.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove authorizes the submittal of a Used Oil Payment Program application to the California Department of Resources Recycling and Recovery ("CalRecycle"); and

**BE IT FURTHER RESOLVED** that the City Manager of the City of Elk Grove, or designee, is hereby authorized and empowered to execute in the name of the City of Elk Grove, all documents, including but not limited to, applications, agreements, annual reports including expenditure reports, and amendments necessary to secure said payments from CalRecycle to support the City's Used Oil Collection Program; and

**BE IT FURTHER RESOLVED** that this authorization is effective until rescinded by the City Council of the City of Elk Grove.
