## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A TASK ORDER WITH KIMLEY-HORN AND ASSOCIATES, INC. FOR ENGINEERING SERVICES FOR THE LAGUNA CREEK TRAIL – CAMDEN SPUR PROJECT IN AN AMOUNT NOT TO EXCEED \$104,479

WHEREAS, the City of Elk Grove Trails Master Plan has identified a level one priority for an extension of the Laguna Creek Pedestrian Trail near Camden Lake to provide access from the existing trail and Camden Passage neighborhood to California Family Fitness and other commercial retail and dining, as well as Bond Road; and

**WHEREAS**, the Elk Grove Trails Committee has recommended the City pursue activities to start this project in the Capital Improvement Program; and

**WHEREAS**, engineering services are required to select a bridge type and support environmental documentation and permitting; and

WHEREAS, staff has solicited and received fee proposals from several of its oncall engineering consultants; and

WHEREAS, based upon evaluation of proposals received, the City has determined that Kimley-Horn and Associates, Inc. is the best qualified of these firms based upon its demonstrated ability, relevant experience in designing bridges, knowledge of the project, and knowledge of the environmental documentation and permitting requirements; and

**WHEREAS**, the aforementioned on-call contract with Kimley-Horn and Associates, Inc. enables the City of Elk Grove to request work covered under the scope of the contract by means of a task order.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a task order with Kimley-Horn and Associates, Inc. for professional engineering services for the Laguna Creek Trail – Camden Spur Project in an amount not to exceed \$104,479.
