

RESOLUTION NO. 2010-172

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO ACCEPT GRANT FUNDING FROM THE OFFICE OF TRAFFIC SAFETY IN THE AMOUNT OF \$170,000 AND AMEND THE POLICE DEPARTMENT'S FISCAL YEAR 2010-11 BUDGET TO APPROPRIATE GRANT FUNDS

WHEREAS, in February 2010, the Office of Traffic Safety announced funding opportunities for local law enforcement agencies interested in implementing selective traffic enforcement programs that heighten awareness of the dangers of driving under the influence; and

WHEREAS, the Office of Traffic Safety has awarded the Elk Grove Police Department a grant in the amount of \$170,000 to implement programs to reduce the number of people driving under the influence; and

WHEREAS, the safety of Elk Grove citizens is the Police Department's primary concern; and

WHEREAS, these grant funds will allow the Police Department to work additional hours to implement the DUI checkpoints and patrols throughout the City of Elk Grove; and

WHEREAS, this grant supports City Council's goal to grow and support safe, livable, attractive neighborhoods.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to:

- 1) Accept a grant award from the Office of Traffic Safety for implementing selective traffic enforcement programs that heighten awareness of the dangers of driving under the influence in the amount of \$170,000; and
- 2) Execute all related award documents required for receiving such funds pursuant to the terms and conditions of the Office of Traffic Safety; and
- 3) Amend the Police Department's Fiscal Year 2010-11 revenue and expense budgets as follows:
