A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
APPROVING THE CITY OF ELK GROVE'S PARTICIPATION IN THE RABIES
VACCINATION AND LICENSE AWARENESS EVENT DURING THE MONTH OF
AUGUST 2010 AND WAIVING THE LICENSE FEE FOR ANY CITIZEN FIRST-TIME
APPLICATION FOR ISSUANCE OF A LICENSE FOR ALTERED ANIMALS
VACCINATED FOR RABIES IN THE MONTH OF AUGUST 2010

**WHEREAS**, the City of Elk Grove desires to bring the importance of pet vaccination and licensing awareness to the community; and

**WHEREAS**, the City of Elk Grove will partner with surrounding jurisdictions to broaden the message of responsible animal ownership; and

**WHEREAS**, it is in the best interest of every community to reduce the number of pets impounded and euthanized.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby approves the City of Elk Grove's participation in the rabies vaccination and license awareness event during the month of August 2010.

NOW, THEREFORE, BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby waives the license fee for any citizen who makes a first-time application for issuance of a license for his or her altered (spayed / neutered) animal vaccinated for rabies. Both the vaccination and the application for license must be made between August 1, 2010 and August 31, 2010. Any such license fee waiver shall be limited to one (1) year. This fee waiver shall not apply to license renewals.
