## **RESOLUTION NO. 2010-163**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDMENT TO THE FUEL SERVICES CONTRACT WITH FERRELLGAS / ELK GROVE GAS & OIL OF ELK GROVE TO PURCHASE BULK UNLEADED GASOLINE AND CARD LOCK FACILITY FUEL FOR CITY VEHICLES BY EXTENDING THE CONTRACT TERM ONE YEAR AND AUTHORIZING AN EXPENDITURE OF FUNDS NOT TO EXCEED \$750,000 FOR A TOTAL COMPENSATION NOT TO EXCEED \$1,500,000

**WHEREAS**, the City provides police services, transit services, code enforcement and integrated waste management vehicles within the City of Elk Grove requiring the use of unleaded gasoline and diesel fuel for daily operation; and

WHEREAS, the City has engaged Ferrellgas / Elk Grove Gas & Oil of Elk Grove to provide the City with bulk and card lock facility fuel; and

**WHEREAS**, Ferrellgas / Elk Grove Gas & Oil of Elk Grove has satisfactorily provided bulk and card lock facility fuel to the City.

**NOW, THEREFORE BE IT RESOLVED** that the City Council of the City of Elk Grove authorizes the City Manager to amend the contract with Ferrellgas / Elk Grove Gas & Oil of Elk Grove for bulk and card lock facility fuel for City vehicles extending the contract term for one year until June 30, 2011 and authorizing an expenditure of funds not to exceed \$750,000 for a total compensation not to exceed \$1,500,000.
