

RESOLUTION NO. 2010-185

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO ACCEPT GRANT FUNDING FROM THE
CALIFORNIA EMERGENCY MANAGEMENT AGENCY AS APPROPRIATED UNDER
THE DEPARTMENT OF HOMELAND SECURITY APPROPRIATIONS ACT, 2010
FOR THE ESTABLISHMENT OF AN EMERGENCY OPERATIONS CENTER**

WHEREAS, the City of Elk Grove is the second largest city in Sacramento County; and

WHEREAS, emergency response preparedness is essential to saving lives and property; and

WHEREAS, an Emergency Operations Center (EOC) in the City of Elk Grove will allow the City to respond to local and regional emergencies in an efficient and coordinated manner; and


WHEREAS, the City of Elk Grove requested and received \$750,000 through the Department of Homeland Security Appropriations Act, 2010 to establish an EOC using an existing facility; and

WHEREAS, there is sufficient funding in the Fiscal Year 2010-11 General Fund budget to contribute \$250,000 in matching funds for an EOC retrofit project; and

WHEREAS, the granting agency requires that the City's governing body approve acceptance of the award and designate an authorized signatory to grant award documents.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to: 1) accept a grant award in the amount of \$750,000 from the Department of Homeland Security through the State of California Emergency Management Agency; and 2) execute all contracts, reports, and other documents required for receiving such funds pursuant to the terms and conditions of the grant.


