

RESOLUTION NO. 2010-194

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE ADOPTING SERVICE ADJUSTMENTS TO REGIONAL E-VAN SERVICES EFFECTIVE NOVEMBER 1, 2010 AND LIMITING REGIONAL E-VAN SERVICES TO ELK GROVE RESIDENTS EFFECTIVE OCTOBER 1, 2010

WHEREAS, the City of Elk Grove (City) provides public transportation service for the benefit of persons in the City of Elk Grove; and

WHEREAS, the City has adopted a budget for Fiscal Year 2010-11 that includes a deficit in the Transit fund; and

WHEREAS, sales tax receipts credited to transportation have been impacted by the current economic climate in California; and

WHEREAS, the City operates significant service beyond the required Americans with Disabilities Act (ADA) Complementary Service Requirements; and

WHEREAS, recent changes to the service area for Sacramento Regional Transit has redirected Sacramento County residents to *e-van* services; and

WHEREAS, the City is committed to providing the maximum level of transit service possible while maintaining fiscal constraint.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove does hereby adopt service adjustments to *e-van*, as set forth in Exhibit "A".

NOW, THEREFORE, BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove does hereby authorize the City Manager to implement the adjustments effective November 1, 2010 and to limit the services offered to residents of Elk Grove effective October 1, 2010.
