**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A PROFESSIONAL SERVICES
CONTRACT WITH WILLDAN ENGINEERING TO PROVIDE SERVICES TO THE
DEPARTMENT OF PUBLIC WORKS IN ACCORDANCE WITH THE REQUEST FOR
PROPOSALS ISSUED JULY 2010**

WHEREAS, the City of Elk Grove utilizes consultants to perform most of the services within the Department of Public Works; and

WHEREAS, the existing professional services contracts for Public Works services will expire on December 31, 2010; and

WHEREAS, a continuation of public works services is vital to the protection of public safety where a lapse of having a contract for these professional services is unacceptable; and

WHEREAS, the City has followed its purchasing ordinance requirements by issuing a Request for Proposals to solicit these services; and

WHEREAS, on August 20, 2010 proposals were received from two companies: Interwest Consulting Group and Willdan Engineering; and

WHEREAS, both companies are qualified to do the work; and

WHEREAS, the proposal submitted by Willdan Engineering was determined to be the better proposal in accordance with the advertised scoring criteria.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a professional services contract with Willdan Engineering to perform the Department of Public Works services consistent with the Request for Proposals.
