A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE REPEALING RESOLUTION NO. 2007-188 AND APPROVING A RESOLUTION RELATIVE TO WORKERS' COMPENSATION BENEFITS FOR REGISTERED VOLUNTEER "DISASTER SERVICE WORKERS"

- WHEREAS, Resolution No. 2007-188 refers to the agency as California Office of Emergency Services; and
- WHEREAS, Section 8585 of the Government Code changes the name of the agency from California Office of Emergency Services to California Emergency Management Agency; and
- WHEREAS, pursuant to Government Code 8585.5, the California Emergency Management Agency has adopted rules and regulations establishing classes of disaster service workers, the scope of duties of each class, and the manner of registration of such volunteer disaster service workers; and
- WHEREAS, the City of Elk Grove desires to become an "accredited Disaster Council" organization in order that injured disaster service workers registered with it may benefit by the provisions of Chapter 10 of Division 4 of Part 1 of the Labor Code; and
- WHEREAS, pursuant to Government Code 8612, the City of Elk Grove agrees to follow the rules and regulations established by the California Emergency Management Agency. The City desires to become certified by the California Emergency Management Agency so the City's disaster Council can become an accredited disaster council and is authorized to register Disaster Service Workers; and
- WHEREAS, the City of Elk Grove desires to register and will hereafter register volunteer disaster service workers.
- **NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby agrees to follow the rules and regulations established by the California Emergency Management Agency pursuant to the provisions of Section 8585.5 of the Government Code; and
- **BE IT FURTHER RESOLVED** that the City Clerk of the City of Elk Grove is hereby authorized and directed to send a certified copy of this resolution to the California Emergency Management Agency for filing with said Office.
