A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE SETTING FEES ASSOCIATED WITH UNATTENDED DONATION BOX PERMITS

- WHEREAS, Chapter 4.13 of the Elk Grove Municipal Code requires property owners of unattended donation boxes to obtain a Permit from the City of Elk Grove (the "City") to operate and maintain all unattended donation boxes within the City; and
- **WHEREAS**, Chapter 4.13 of the Elk Grove Municipal Code establishes and requires compliance with regulatory and operational standards by the applicant in order to legally operate an unattended donation box; and
- WHEREAS, Chapter 4.13 of the Elk Grove Municipal Code will require permitted property owners of unattended donation boxes to annually renew said Permit; and
- WHEREAS, Chapter 4.13 of the Elk Grove Municipal Code provides that the City Council may establish, by Resolution, a fee for the costs of regulating an unattended donation box Permit; and
- **WHEREAS**, the project is exempt from the California Environmental Quality Act (CEQA) pursuant to Guidelines Section 15061(b)(3) ("General Rule") and 15273 ("Rates, Tolls, Fares, and Charges") of Title 14 of the California Code of Regulations.
- **NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Elk Grove:
- <u>Section 1. Recitals.</u> The foregoing recitals are true and correct and the City Council so finds and determines.
- <u>Section 2. Establishment of the fees.</u> The fee schedule to permit an unattended donation box under Chapter 4.13 of the Elk Grove Municipal Code is established as follows:

Permit \$132.00 Renewal fee \$66.00

<u>Section 3. Collection of the fee.</u> The fee levied pursuant to this resolution shall be paid to the City of Elk Grove at the time of permit application and annually upon renewal.
