RESOLUTION NO. 2010-237

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
APPROVING THE ABANDONMENT OF A PORTION OF AN EASEMENT FOR THE
TRANSPORTATION AND DISTRIBUTION OF ELECTRICAL ENERGY AND
INCIDENTAL PURPOSES AS RESERVED FROM THE ABANDONMENT OF A
PORTION OF WEST STOCKTON BOULEVARD BY RESOLUTION NO. 2008-237

WHEREAS, the City abandoned a portion of West Stockton Boulevard by Resolution No. 2008-237 and quitclaimed the underlying fee to adjacent property owners within Lent Ranch Marketplace; and

WHEREAS, the City reserved an easement for the transportation and distribution of electrical energy described as "Easement No. 2" in Resolution No. 2008-237 for the purpose of maintaining an existing Sacramento Municipal Utility District (SMUD) 69 kilovolt line that was located on pole lines; and

WHEREAS, said 69 kilovolt line, within a portion of the aforementioned Easement No. 2, has been relocated to towers in a new easement granted to Sacramento Municipal Utility District (SMUD), and the old poles have been removed.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby finds:

- 1) The proposed abandonment is exempt from environmental review pursuant to Section 15035 of the California Environmental Quality Act guidelines; and
- 2) The abandonment is being made under the Streets and Highway Code, Division 9, Part 3, Chapter 4, Summary Vacation Sections 8330 through 8336 inclusive; and
- 3) This easement is being abandoned as is described in Exhibit A Legal Description; and
- 4) The easement being abandoned is superseded by relocation and there are no other public facilities within the easement; and
- 5) The proposed abandonment is consistent with the City General Plan and Section 65402 of the Government Code.

NOW, THEREFORE, BE IT FURTHER RESOLVED AND ORDERED that a portion of an easement for the transportation and distribution of electrical energy as described in Exhibit A is hereby abandoned; and

NOW, THEREFORE, BE IT FINALLY RESOLVED that the City Clerk of the City of Elk Grove shall cause a certified copy of this Resolution of Abandonment and Exhibit A attached hereto attested by the City Clerk under seal, to be recorded in the Office of the County Recorder of the County of Sacramento.
