**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
ACCEPTING THE POPPY RIDGE STREET LIGHT REPLACEMENT / RETROFIT  
PROJECT AS COMPLETE AND AUTHORIZING THE CITY ENGINEER TO  
PREPARE A NOTICE OF COMPLETION AND THE CITY CLERK TO FILE THE  
NOTICE OF COMPLETION WITH THE SACRAMENTO COUNTY RECORDER**

**WHEREAS**, on April 14, 2010, the City Council awarded a construction contract to Republic Intelligent Transportation Services, Inc. to construct the Poppy Ridge Street Light Replacement / Retrofit Project (Capital Improvement Project ID PT0106) (Project); and

**WHEREAS**, the project involved retrofitting 435 existing High Pressure Sodium street lights of various sizes and wattages with energy efficient Induction Street lights throughout the Poppy Ridge Community Facilities District (CFD 2003-1) area; and

**WHEREAS**, Republic Intelligent Transportation Services, Inc. has completed the work in accordance with the contract documents for the Project; and

**WHEREAS**, if no liens or claims have been filed within 35 days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Republic Intelligent Transportation Services, Inc.


