BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby finds the following as required by the Government Code Section 66001(d) and based upon review of the Annual Development Impact Fee Report for Fiscal Year 2009-10:

- 1) That the purpose of the development impact fees has been identified;
- 2) That there is a continued need for the improvements and that there is a reasonable relationship between the fees and the impacts for development for which the fees are collected;
- 3) The sources and amounts of funding anticipated to complete the financing of improvements have been identified; and
- 4) The approximate dates for funding improvements are included in 2010-15 Capital Improvements programs unless the improvements are longer term projects.
