WHEREAS, on September 8, 2011, the City Council authorized the award of a construction contract to Valley Slurry Seal Company to construct the Harbour Point Drive Median / Rehabilitation Project (Capital Improvement Project ID PT0131) (Project); and


WHEREAS, Valley Slurry Seal Company has completed the work in accordance with the contract documents for the Project; and

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Harbour Point Drive Median / Rehabilitation Project (Project) as complete.

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.
